NESC: The NESC business was reviewed.

Education Enhancement Foundation: No reports.

<u>Legislative Report</u>: Roth shared the 2024 legislative session has begun and people can stay informed about education bills by using the ASBSD Bill Tracker at asbsd.org.

<u>Buildings/Facilities Committee Report</u>: Superintendent Abi shared that the construction of LIW elementary is still making progress. They are currently working on painting, wiring, and ceiling grid. By the end of the month, casework will be installed, as well as HVAC, sprinklers and electrical items. Superintendent Abi also shared that the district was awarded a Clean Diesel Grant to be used toward the purchase of a new diesel bus.

Administration Reports:

Business Manager Johnson shared fuel cards have arrived and will be used instead of store charges; online timeclock will be implemented for the next pay period; the Food Service On-Site Review was held Jan 10; and working on end of calendar year documents.

Principal Bettin shared the following students will advance to State FCCLA in April: Arora Peaz-Cook, Courtney Smith, Kimber Efraimson, Haizel Koistinen, Remi Efraimson, Adalyn Gross, Kashden Palmlund, Rhys Hendrickson, and Kaden Koistinen; NHS Blood Drive was held Dec 13 at the Event Center; Student Council hosted a food drive competition to support the local food pantry; Head Track Coach position is still open; attending Principal Mentor webinar on Dec 13; 2nd quarter ended on Jan 6; early dismissal on Jan 12 for in-service; no school Jan 15 for MLK Jr. Day; and Middle School Awards on Jan 17. There was a snow day on Jan 8 and the make-up day will be Feb 19.

Principal Abi shared the elementary the surprise PBIS Reward in December was a magician; 3rd grade recently learned about the Midwest Honor Flight and will be hosting a hat fundraiser for the program on Jan 19; and Regional Teacher In-Service will be held Feb 16 in De Smet with five area schools participating.

President Roth shared that SDRS Board of Trustees has an opening for a school board representative. The four-year term begins July 1, 2024. The board expressed their support in Roth pursuing the open position.
