Reports

NESC: The NESC business was reviewed.

Education Enhancement Foundation: No report

Legislative Report: President Roth reminded others of the ASBSD Bill Tracker, an online (asbsd.org/services/billtracker-2/) resource to track education-related bills for the 2025 SD Legislative Session. One of the hot topic issues in the legislature will be voucher schools. Dr. Abi reminded the board of the pipeline meeting on Jan 16 at 11:30am at the Event Center.

Buildings/Facilities Committee Report: Dr. Abi reported that demo of the old LIW classroom wing will take place in the next week or two. The 2025 Thomas bus ordered last spring will arrive in the next couple of weeks. The District plans to purchase a mini bus with the recent Clean Diesel Grant award. The new elementary school is experiencing some exterior drainage issues that will be addressed this spring. Co-op Architect was on site to review a few ongoing items from the recent construction.

Teacher Report: Mrs. Palmlund reported that she has transitioned to Title teacher and will be working on STAR testing. Ms. Seifert was hired to fill the culinary position for the remainder of the school year.

Administration Reports:

Business Manager Johnson reported that Smart Sense thermometers have been installed in the kitchen and working well. The school collaborated with the Kingsbury County Cattlemen's Association to host a burger feed on January 2 for the Beef-to-School Program. The proceeds will cover processing fees this spring. Donations can be made throughout the year by contacting the business office. During the KCCA Banquet on January 11 the De Smet FFA Project (cattle panels) was auctioned off for \$3500, which earned the Beef-to-School program an additional \$250!

Principal Bettin recapped events from December. Financial Aid Night is rescheduled for January 15. The ASVAB was administered to juniors on December 18 with an average score of 46.4 (National Average is 50.0). The average ACT score earned for De Smet students this fall was 18.5 (the National Average is 19.4). The MS/HS math teachers are researching new curriculum. Upcoming events: Jan 15-MS Awards, Jan 16-Bulldog Buddies, Jan 17-Early Dismissal/Teacher In-Service, Jan 22-Regional One Act in Brookings, Jan 22-23 FFA Legislative Days in Pierre, Feb 10-14 FCCLA Week, Feb 14-No School/Teacher Regional Inservice.

Superintendent Abi attended an Educator Rising event at University of Sioux Falls with a couple De Smet high school students. Staff will attend dyslexia training on January 14. There will be an early dismissal on January 17 for teacher in-service at 1:30pm. January 20 will be a make-up day with school in session.

<u>Practice on Weather-Related Early Dismissals</u>: The board discussed holding practices/open gym on weather-related early dismissals. The board recommended that no practice or extra-curricular events are held when school is closed due to inclement weather.

Discussion on Audit Company for FY2025: Business Manager Johnson shared that the audit for FY2024 has yet to be scheduled. The district is still in compliance as SDCL 4-11-7.1 requires school districts to have an audit performed at least every two years. However, the board and administration feel it is important to have annual audits completed. The board reviewed quotes from Schoenfish and ELO for the FY2025 audit, but did not take action. Johnson will inquire about having Schoenfish doing a one-time two-year audit and then get back on track of doing annual audits in the fall.
